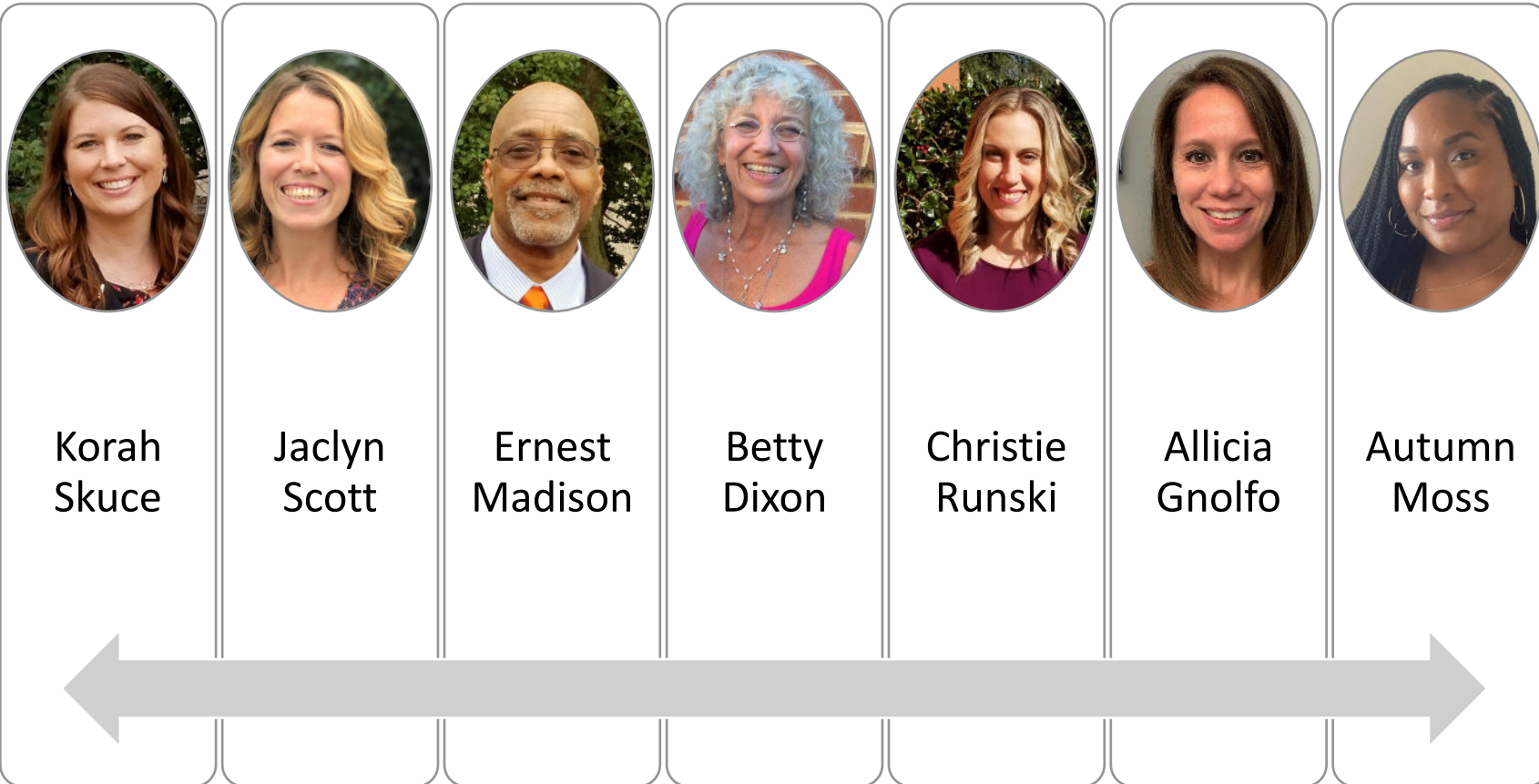

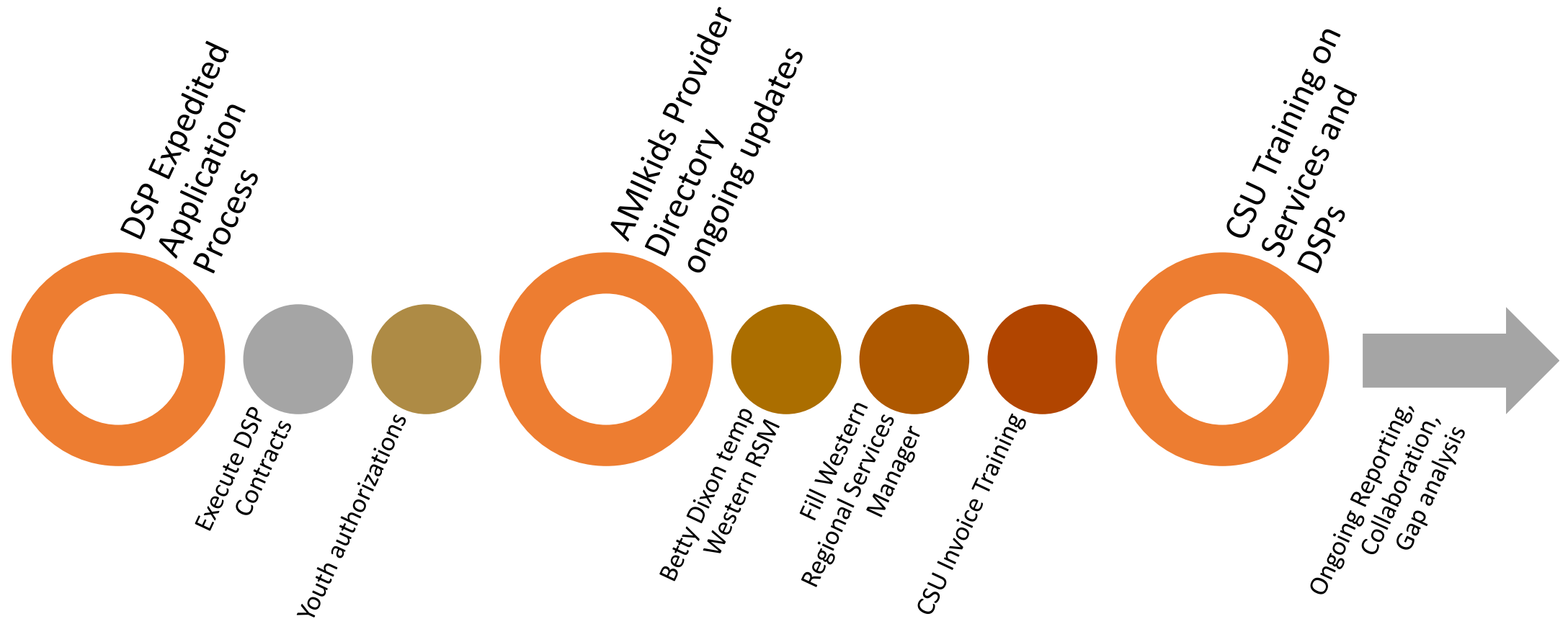

- Begin redirecting all referrals and extension packets to: VAServices-Referrals@amikids.org
- RSC model is same statewide with universal referral form and practices / deadlines
- AMIkids will continue to CC you on all new Authorizations. For current cases, AMIkids and EBA will work together to transfer open authorizations from EBA to AMI for September 1st
- All AMIkids referral packets are initially reviewed by Allicia Gnolfo to ensure complete packet
- Although similar billing processes, Christie Runski will hold a webinar for your fiscal team to review billing practices. Fiscal calendar and deadlines are the same.

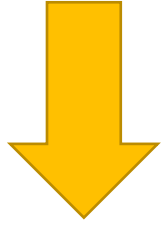
