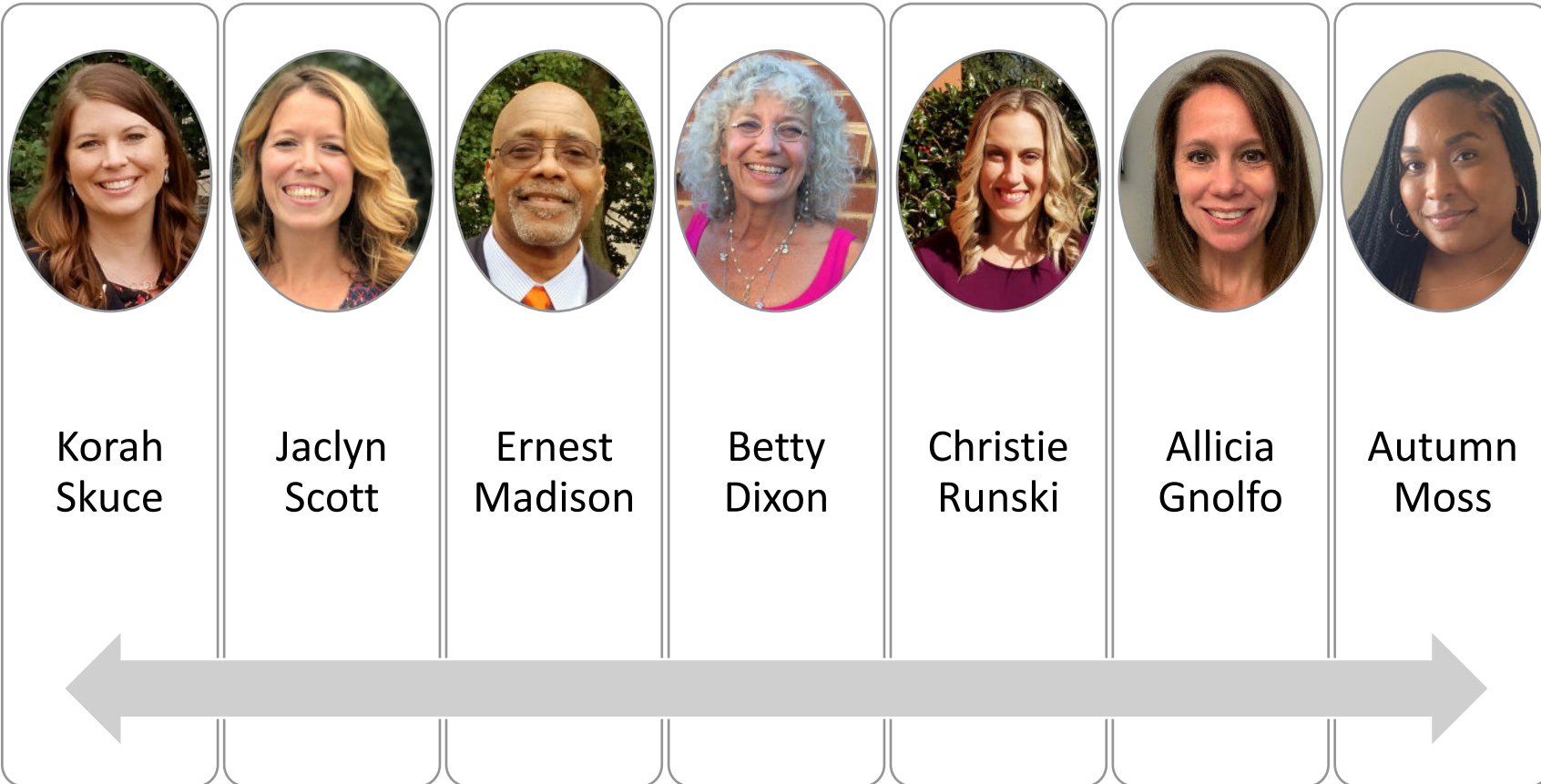

# New Provider Contract Checklist

---

- 1 Complete the online (expedited) New DSP Form <https://forms.office.com/r/CCJsYt81qb>
- 2 Submit Certificate of Insurance OR copy of full policy if unsure it meets criteria
- 3 Update COI to list AMIkids and DJJ as additional insured
- 4 Submit DBHDS or DSS License
- 5 Complete Workbook to show services and localities to add to contract and our provider directory
- 6 Review and Sign contract (let us know if need corrections before you sign)

- 2. Send new service information (descriptions, rate structure)
- 3. New contract to be executed in September
